Mold Horror

If the results of the samples indicate that the amount of mold growth indoors is significantly greater than the mold growth outdoors or the type of mold(s) found indoors is significantly different than the mold growth outdoors, then you have a mold problem. There is the option of sending away the test sample for further analysis.

We didn't get a chance to look at our specimens until a week later. The outdoor specimen was completely covered with a technicolor jungle of tiny plants, bushes and trees. The indoor sample had only a couple of small growing spots. So we really don't have a problem in that unit. We opted however to have the sample tested by the lab for an additional \$30. So we sealed the petri dish and sent it off to be tested. Results in the next issue.

If you have a mold problem, before you give hundreds or thousands of dollars to men in "ghost buster" suits for remediation, here are some tips:

- You don't have a mold problem you have a moisture problem. Fix leaks; make sure there is adequate ventilation. Maybe get a dehumidifier. When the heating season is in full swing everything is sure to dry out.
- 2. Cleanup the mold. Hey folks, pay attention, before buying expensive cleaning products, Feldt says the top companies use Dawn dishwashing liquid.
- 3. There is no such thing as a 'Certified' mold remover or remediation company although there are several contractors that will do it for you if you don't want to do it yourself.
- Since we have done considerable research on this topic call me if you have any questions, Al Emmons 423-1133. I would be glad to look into your special situation. (No charge)

GONA Meetings Can Answer Your Questions

Some people put metal lath on the outside of a Greendale Original home in preparation for stucco. That is not wise (there are alternative products). In this day of wireless cell phones, internet and TV, metal lath interferes with wireless service.

Come to a GONA meeting before considering home projects. We are YOUR owners' association and have researched methods because of the unique character of our building structures. We can help you research to make an informed decision. Don't make costly mistakes!

At GONA we are aware of some instances where Greendale Original homeowners made some serious mistakes on their homes. However well intentioned, some things are not only a waste of money but can affect the comfort and safety of your home.

There is a contractor who proposed to insulate the interior of the exterior walls of a crawl space. This can cause serious damage to foundation walls due to freezing. The block then will explode and fall into the crawl space. Another home owner spent thousands of dollars for mold cleanup when the mildew (mold) was not harmful and could have been easily removed with detergent. (Test kits for testing for dangerous mold are \$10.)

Homeowners were told by a contractor that siding removal would cost \$15,000 because it had asbestos in it. That's a scare tactic! We had the siding tested. An \$18 lab test revealed that it did not contain asbestos. The home owner removed the siding himself and made \$300 selling it to a recycler!

When you call contractors to help you solve a problem they will address it by advising you to buy what they know how to do. They may be sincere, but it may not be the best way for our unique structures. An example is cracked roofing tiles that cause a leaking roof. The roofing contractor recommends tearing off the 70-year-old roof and replacing it with a new shingle roof because he doesn't know how to fix our unique clay or slate tile roofs. But by doing that you are replacing a 500-year-roof with a 20-year-roof, when for less money than a new roof you could have replaced the roof tiles and maintain the integrity of the structure. As an added feature it helps keep the historical character of your Greendale Original (and is worth more money).

For help with maintenance issues and renovations of your "original," join us at a meeting. We are a friendly bunch, (and Karyn brings cookies).

Dog Gonet! Loose Dogs Frighten Some

How nice it is to walk in our village. It is a special benefit of living here. It's so beautiful and serene....then suddenly a loose dog comes charging toward you. Terrifying! You bet! I don't believe that pet owners' realize that heart palpitating instant of fear that grips you. They act like it is your fault for being scared.

Somewhere, some place, some time, society established a leash law that they thought would solve this problem. Greendale adopted such a policy.

Recently, a resident attended a GONA meeting and told of his experience with a loose dog in the park, and its owner. Remember that even though the owner is nearby, and maybe the animal only wants to 'play,' it can be very frightening when a dog charges in your direction.

We have heard comments that it's "no big deal" when the pet is friendly, or if smaller, or of a certain breed, a leash is not required. Not true.

GONA would like to help both sides. We're here to help, so we researched what you can or cannot do.

- A dog must be leashed and controlled at all times when not on the owner's own property.
- According to Village Ordinance 12.04 "When an animal is off the premises of its owner and upon any public street, or alley, school grounds, public park or other public grounds or upon private property without the permission of the owner of the property; provided, however, that an animal shall not be deemed at large if
 - (a.) It is attached to a leash not more than 10 feet long, of sufficient strength to restrain the animal and the leash is held by a person competent it control the animal and prevent it from annoying or WORRYING pedestrians or trespassing on private property or public property where such animals are forbidden, or
 - (b.) It is properly restrained within a motor vehicle."

Another Ordinance 9.08.5(a) states that dogs and cats are not to run at large. "Prohibited. No owner or other person in control or having custody of a dog or cat shall allow the same to run at large within the Village unless accompanied by and under the control of the owner or keeper."

Pick up Poop

It is hard to believe that people don't know that it is also a requirement (a law, Ordinance 9.08.3) that dog feces must be picked up by the person in charge of the animal. It must be that they don't know, or care, because the sight of new fallen snow is blemished here and there by brown splotches. So remind the dog walkers and help keep Greendale green and "poop free".

We love pet owners and especially want them to be our friends. Consideration for others avoids conflict and confrontation that the walkers never wanted in the first place.


